

SOME CURES FOR THE TEXT BOOK BLUES

Textbooks cost a lot of money and this is nothing new. The textbook industry is a racket and we, the students, are the ones getting screwed. Well, we here at The Red Pill have compiled a number of ways for you to get free or cheaper text books next semester.

Use your contacts. Borrow textbooks from friends that have already taken the class. If the book is a different edition, don't let that dissuade you from using the book; most of the time very little in the textbook has changed, they just want to increase their sales by making old editions arbitrarily obsolete.

If you have a class like Shakespeare, 18th Century Literature, or American History, where most of the works are now in the public domain, just head over to the computer lab and search for PDFs of the books on the web and then print them out on the school's dime. www.pdfplanet.com has thousands of public domain books PDFed. Pretty much any book or play written before 1900 is going to be available in PDF on the web. Some file sharing networks also have bootleg PDFs of current books, as well.

Believe it or not, most text books that professors assign are already on the shelves in the school library; be the first to check it out and you could save a wad of cash.

The internet is also a good source of cheap books. Sites like www.textswap.com, www.bookins.com, www.collegesmart.com are all dedicated to trading books between students around the country. Amazon.com can often save you 50% off what the bookstore monopolies will charge you.

Abbie Hoffman, in his counterculture masterpiece, *Steal This Book*, suggested that: "If you need books for a course, write to the publisher claiming you are a lecturer at some school and are considering using their book for your course. They will always send you free books." The text book companies are always sending professors books to consider for their classes, because if a professor chooses their book they know all the students will have to buy it. I would go a little further than Hoffman and suggest the next time the college sends you a letter, photo copy the letter with a blank piece of paper over the body; the xerox should leave you with a perfect copy of your college's letterhead, which should cinch up this little scam.

If you have a trustfund, scholarship, or rich uncle that reimburses you for your textbooks, buy a few extra books—copy your original receipt, and send the copy to the appropriate party—and then return the extra books with the receipt for a little pocket cash. •

GANG VIOLENCE ROCKS BUENA VISTA PRISON

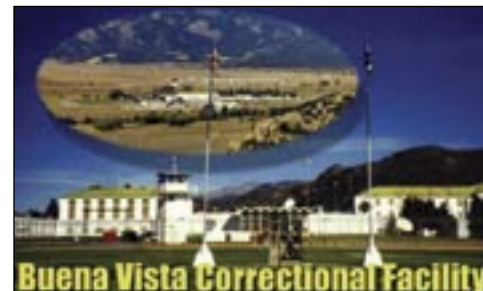
One of Colorado's largest prisons, Buena Vista Correctional Facility, has been rocked by gang violence. The 1,218 bed facility has been on lock down since a major assault took place on April 29th in east unit. The violence, between

two hispanic street gangs, the Nortenos and the Surenos, resurfaced again on May 6th. A third incident, a stabbing, may have occurred in the south unit, but Alison Morgan, the Colorado Department of Corrections (CDOC) spokesperson, denied that a stabbing or any incident had taken place in south unit. Posted on the CDOC's website, however, was an announcement that read, "There will be normal visiting at Buena Vista Correction Facility *except* for those Offenders housed in the South Unit."

An anonymous inmate inside of Buena Vista wrote to The Red Pill about the situation:

"It's been real fucked up as of late around here. On Sunday the 29th of April there was a gang war in the unit I'm in. I'm pretty sure one guy was killed! ...The Surenos and Nortenos got into it. There was 12 or 15 guys involved, and by the time it was over one Sureno was laid out on the floor, not breathing and blood coming out of his mouth and ear. It has been an on going situation ever since. We have been on lock down since that Sunday. We still come

out for chow and showers. There have been 5 or 6 other incidents. Just the other day there was a stabbing in south unit and someone was jumped in the chow hall. Things are cool for a day or two and then something goes down again. The Cops went through a bunch of



cells and found approximately 10 shanks [prison knives]! This is the worst place I've ever been. Well at least I get out soon (if I live that long)."

Morgan said that the inmate assaulted on the 29th is still in the hospital, and that his injuries were not life threatening.

Morgan also confirmed that "non-lethal Stinger rounds," which consist of small rubberized pellets, were used to regain control during the May 6th incident, which took place in the chow hall. Morgan added that, "staff responded quickly, professionally, and decisively."

Morgan also confirmed that the Buena Vista prison is on 'modified lock down' which is standard procedure after a major assault.

"It is a challenge to manage the inmate populations, and it is a challenge to limit gang activity inside

the prison system."

The Chaffee County District Attorney told The Red Pill that he was aware of the incident, and that charges are expected to be filed, but was unable to comment any further.

Fire is alive. It has to breathe, or it will die. It will have to eat or it will starve. When you follow its trail, it seems to think. And seeing it in the hands of The Burning Fire Desert Collective, it's obvious that fire loves to dance.

The Grand Valley is full of talented and artistic people, and the Burning Desert Fire Collective is rapidly searing itself into the local collective consciousness. "We are ambassadors of the flame which burns in everyone," says group spokesperson, Abbie Moore. "We consider ourselves muses." This is easy to feel when you watch the collective perform, especially some place dark. You smell the flame, it whirs and whooshes by the dancer, paints lines of light, adding a primeval ambience to the show.

The group has used fire creatively, alone and in teams, with batons and flaming jump-ropes, but its fundamental unit is the dancer and the poi. The

poi is a little steel basket at the end of a chain that contains the burning wick and is spun.

The Burning Desert Fire Collective bases much of its style on the Maori of New Zealand. Therefore, there is a strong spiritual bent to their actions. To the average person, the rush of the ember and the sound of the whoosh is just pretty damn cool.

An exciting collaboration is taking place at this time. Members of Burning Fire Collective are working with members of the valley's Tribal Fusion Belly Dancers. The early results point to something exciting coming in the not-so-distant future. Artists are reversing roles with other artists and magic is happening. SIT-IN AT SALAZAR'S

In April 16th, tax day, local peace group, A Voice of Reason, staged a sit-in at Senator Ken Salazar's (D) Grand Junction office to demand "that our tax dollars be spent only toward: withdrawal, humanitarian reconstruction of Iraqi infrastructures, reparations for the Iraqi people, and support for the troops and veterans in the form of rehabilitation and re-integration."

Salazar has stopped short of supporting a withdrawal from, or defunding of the war in Iraq.

During the hour-long sit-in, 13 people sat on the floor in Salazar's office and read the names of the U.S. troops that have died in Iraq. Thirty-five people rallied at the street level in solidarity. After the sit-in was over, a breakaway group of high school and college-aged protesters marched up and down Main St. in a small, but feisty procession. •



DEATH BY COP:

Nathaniel Jones, 41, was inadvertently caught in the police video one hot Cincinnati night. Disoriented, surrounded by cops, he suffered 40 blows from nightsticks, pepperspray, tasers, and was hog-tied by handcuffs. His last audible words were "mother...mother." The autopsy showed no drugs in his system that night. The medical examiner put down the cause of death as 'excited delirium,' a condition not recognized by the American Medical Association or the American Psychiatric Association.

Almost literally, every single death from 'excited delirium' involves cops, tasers, and pepperspray. Dr. Vincent Demad of Bexar, Texas calls it, "an overdose of adrenaline." It's often the very act of resisting that sends people prone to 'excited delirium' over the top. Cops dehumanize

the victims, often completely innocent, by accusing the victims of having 'superhuman' strength. Other signs indicated are bizarre behavior, paranoia, panic, and the aforementioned unexpected strength.

Both the ACLU and the NAACP reject any designation such as 'excited delirium.' They cite Warren S. Pitz, chief medical examiner, in the state of Michigan, "For psychiatrists, this condition is exceedingly rare. Suddenly, it's showing up in medical examiners' reports, but police are always involved."

No cop has ever been convicted on an 'excited delirium' case in the U.S. Dawn Edwards, of the Ella Baker Civil Rights Group, said that people are dying at the hands of police, and "ultimately, it's cops responsibility to keep someone alive when the police have them in custody." •

THE CRIMINAL CIA

“The CIA [is] committing crimes against humanity with de facto impunity and Congressional sanctioning.”
Into The Buzzsaw

The Central Intelligence Agency, or CIA, has officially been in existence since 1947 when President Truman enacted the National Security Act, but it is actually descended from the Office of Strategic Services (OSS) created during World War II. Its primary role is to acquire and analyze information about foreign governments, corporations, and individuals, and relay the intelligence to the United States government. It also serves as a propaganda and public relations apparatus, and it disseminates information, both true and false. The CIA also regularly engages in covert operations carried out on foreign soil to influence the political and/or economic system of the country.

But what goes on inside the CIA itself? A document, recently uncovered by researcher Micheal Ravnitzky, lists the closed internal investigations that the CIA Inspector General conducted between 1997 and 2004. Although much – if not most – of this 56-page document is censored, it still lends an interesting insight into the CIA's criminal activities, controversies, and scandals that seemed to occur on an almost daily basis. It should be noted that this is just a list of completed investigations, and does not indicate whether guilt was established or not.

Some of the most common and mundane investigations include: time and attendance misuse or fraud; theft of government property, including monies; misuse of credit cards, computers, or other government property; frequent flyer or voucher abuse or fraud; violation of patents; questionable or fraudulent accounting or accounting discrepancies; retaliation for reports of abuses and complaints; bribery, illegal gratuity, false statements; false reporting on applications; conflict of interest; a half censored statement involving a bingo game; abuse of position or power; telephone abuse; contract irregularities; alcohol consumption; questionable conduct; plagiarism; privacy violations, breach of confidentiality or misuse of private information; unauthorized dissemination of information; questionable relationships within the CIA, either from employee to employee, employee to contractor, or supervisor to subordinate, etc.; embezzlement; poor management; nepotism; impersonation of a CIA agent or misuse of CIA identification; extortion; failure to pay official debts because of non-sufficient funds; violation of export laws; misuse of the Agency logo; inappropriate behavior; unclassified network intrusion (hackers - x2); favoritism when awarding contracts; insider trading.

Some of the more serious investigations include: lack of action to a security threat (x1); lying to or misleading congress (x3); improper disposal or destruction of classified information (x6); mishandling of classified information (x4, including leaks x2);

interference with local government (x1); violation of law/regulations/policies (x6, one incident involving human rights); failure to report violations (x1); participation in abusive interrogation (x1); sexual harassment or impropriety (x2); pornography (x11, including child pornography x8); receipt and/or shipping of weapons (x3, including an AK-47 x1); illegal activities (x1); drug trafficking (x2); fabrication of background investigations (x2); missing weapons (x2, including hand grenades); obstruction of justice (x2); omission of facts from official reports (x1); privacy act violations (x3); alleged politicization (x2); pedophile (x1); unlawful raid on premises (x1); concealment of terrorist related information (x1).

The document also refers to such things as the CIA involvement in Honduras in the 1980s, experimentation on the brain, biological experiments in Vietnam, the CIA-CONATRA cocaine connection, Iran-Contra, dumping hazardous materials into the Potomac River at CIA headquarters, bombing of the Chinese Embassy in Belgrade, a deadly force incident in Iraq, and wrongful death of a former CIA officer. •

BLACKWATER: AN AMERICAN MERCENARY IN IRAQ

What do you think of when you hear of private contractors in Iraq? Chances are you don't think of elite armed mercenaries providing essential services and security, but that is one of the realities of our occupation. Blackwater USA is a name you may not have heard of, but should, for it is a prime example of improper privatization of crucial security functions in Iraq.

According to its website, Blackwater USA is a professional military, law enforcement, security and peacekeeping firm capable of training, equipping and deploying public safety and military professionals, creating ground and aviation operations and logistics support packages, and more. The company describes itself as “The most responsive, cost-effective means of affecting the strategic balance in support of security and peace, and freedom and democracy everywhere.”

Blackwater was founded by one Erik Prince, a former Navy SEAL and intern under the first Bush Administration, from a family with a history of contributing to the GOP. After 9/11 and the declaration of the “War on Terror,” the firm's range of tasks expanded dramatically to include bodyguarding and aerial surveillance for the Departments of State and Defense, and U.S. intelligence agencies. In 2003, while Paul Bremer was the American ambassador to Iraq, Blackwater undertook guarding him for an eleven-month period, for a bill of \$21 million. In today's occupied Iraq, Blackwater has come to play a significant role, providing field snipers, translators, and interrogators in addition to security for VIPs and the U.S. civilian workforce that finds itself in the middle of an unstable country racked by violence. Performing such high-priority duties, a Blackwater employee may earn as much as \$60,000 a month, far more than a

member of the Army or Marines.

Even a well-paid company like Blackwater is not above the problems present in a hostile occupied zone. After the company got a contract to do security for convoys delivering kitchen supplies to army bases, the notorious “Fallujah Four” incident occurred, in which four Blackwater employees on such an operation were ambushed and killed and their charred bodies were hung from a bridge. The mothers of the four are currently suing the company to release details of their sons' deaths, and are claiming that inadequate preparation and equipment contributed to the incident.

Blackwater claims it is not responsible for the deaths because the four were part of the “total force” operating in Iraq and the deaths were the result of the overall security situation there, for which the U.S. presence as a whole is responsible. This assimilation of a private company as a legitimate part of the U.S. occupying force is unsavory to be sure, but it is backed up by the policy of the government departments concerned. The 2006 Quadrennial Defense Review envisions more use of such contractors as integral parts of the “total force” in the future, while the previous QDR, released before 9/11, didn't even mention the idea.

In any case, the presence of war-profiteering companies like Blackwater USA, which is one of several such companies to receive contracts with the U.S. military during the “War on Terror,” continues. In Iraq, there are currently 100,000 employees of such companies, and their role shows no sign of diminishing until the troops are withdrawn. Last year, the security contract for protecting the U.S. Embassy in Iraq, America's largest foreign embassy, was awarded to, you guessed it, Blackwater USA! •
